### SELECTION CRITERIA

1. Be an employee of an IFDA firm member (licensed or non-licensed), Individual Member, Senior Member or Associate Member.
2. Answer the following 2 questions via written document (250 words or less per question) or a 2-minute video
  - a. Why are you choosing this event?
  - b. How do you feel the event you chose will help you in your career?

### REQUIREMENTS

1. This is a reimbursement scholarship. If awarded, recipient must present receipts for the following expenses to be reimbursed up to \$2,000. If expenses exceed \$2,000, they will be at the responsibility of the recipient:
  - Registration
  - Travel (airfare, car rental, or mileage at \$.56/mile)
  - Hotel
  - Meals (no alcohol) up to \$100/per day (itemized receipt)
2. Write a synopsis or summary (at least one paragraph) of what the event/scholarship meant to you.

**Reimbursement will not be granted if either of these requirements are not submitted.**
